Attached you will find the advertising sales agreement for this year's state finals. **All contestants in the High school division and the Junior High division are required to sell \$150 in Yearbook Sponsorships. Youth contestants will need to sell \$50.00** Please see the following table for due dates:

Division	First Required Turn-In	Second Required Turn-In
High School	March 13th- Conway (\$150)	March 20th - Westminster (any additional ads)
Junior High	March 21st - Westminster (\$150)	April 11th- Chesterfield (any additional ads)
Youth	March 14th- Conway	April 11th - Chesterfield (any additional ads)
Shooters	February 28th - Chappells	April 11th - Chesterfield (must be turned in or mailed in by April 11th)

- You will earn back half of all program ad monies sold past the initial required amount in sales from \$25-\$150 Ad options. The money earned can go toward your trip to the Finals Rodeo or other rodeo expenses. Vendor ads, Chute gate ads and Event sponsor ads **DO NOT** count towards the 1/2 back monies but do count towards your total required to sell.
- Fill out the attached form for each ad sold. **(YOU NEED TO USE THE CORRECT FORM FOR YOUR DIVISION!)** Please fill out the form clearly. Also make sure that

all information for the yearbook ad is attached. It is very difficult to make an ad for the Yearbook without the art.

- We can not share ads between the divisions. Each division earns their own money and has separate accounts.
- Ads must be print ready! We will not design ads.
- No cash will be accepted for payment!
