

SCHSRA Guidelines

*New updates are highlighted in yellow

General

1. Entry Fees will be \$30.00 per event at all SCHSRA qualifying rodeos. \$15.00 of each entry will go to the jackpot. SCJHD - entry fees will be \$30.00 per event at qualifying rodeos. \$11.00 of each entry will go to the jackpot.
2. There will be a 30 second time limit in each timed event. Each event will be timed using electronic timers. Hand-held stopwatches will be used as a back-up to the electronic timers.
3. Roping events will be limited to one loop at all qualifying rodeos.
4. High School Breakaway must be a bell collar catch or will receive a no time.
5. Each contestant wanting to enter an event must make a call-in via on line entry to the rodeo secretary on the published call-in date. No late entries will be accepted.
6. In the team roping and in the ribbon roping event in the Junior High Division, a draw partner can be used four (4) times per year. The draw can be implemented due to med outs or vet outs. In the High School Division, a draw partner may be used eight (8) times per year. If a death occurs in the family (mother, father, siblings, paternal grandparents or maternal grandparents), the draw can be implemented. The draw partner will not pay an entry fee. The draw partner will receive no points or jackpot money. Refer to the NHSRA rulebook on procedures or call us if you have questions.
7. **In the team roping and in the ribbon roping events in the Junior High Division and in the team roping event in the high school, both contestants must complete call in to enter any rodeo. In the event one partner does not call in by the end of Call In, the team will not be entered.**
8. In the RCH/Cutting events, SCHSRA elects to not have these events at every rodeo. Option 2 from the rulebook is used.
9. **In the barrel racing and pole bending, no assistance from a helper can be given, this includes contact with the horse or any equipment past the forward motion tape. The helper can also not go past the plane of the main arena gate. A no time will be given if either occur.**
10. Awards will be determined each year. For year end ties, awards will be duplicated.
11. If a contestant is disqualified for any of the offenses listed in the rulebook, they will be disqualified for the rodeo.
12. In the shooting events in both junior and high school, SCHSRA elects to not have these events at every rodeo. Fees and payout will be the same as other events. Participants will be required to complete the same fundraising efforts as other members. Points will be distributed in the same manner as any other rodeo events. Travel money, if available, will be dispersed in the same manner as any other events. Saddles will not be given in the shooting events.

State Finals

13. In order to qualify for state finals, contestants must attend 40% of the qualifying rodeos/shoots/cuttings/RCH events in the specific event.
14. Every contestant that qualifies for state finals will compete in the 1st and 2nd round of the state finals. The short round will consist of the top 10 in each event as calculated by points after the second round. The short round will be worked from the last qualifying position down to the first qualifying position except in the barrels, poles, cutting and RCH event. In those specified events, running/working positions will be drawn.

National Finals

1. The National Finals Team will be selected as described in the national rulebook. If travel reimbursement is available, it will be dispersed after the first round and after each qualifier has met the criteria of completing two separate national activities that will be determined each year.
2. If reimbursement is available, each National Team Member will receive a \$150 reimbursement for each horse stall that was qualified for. The board will decide the amount of travel money issued based on availability.
